ART. 1 FINANCIAL REQUIREMENTS

The Art. 3 of the Call for assignment of Financial Aid Benefits A.Y. 2025/2026 – issued by the Management Decree Ref. 0130618/2025 (hereinafter also “the Call”), is supplemented as follows:

ISEE/ISEEU Parificato and ISPE/ISPEU limits

Students requesting Financial Aid Benefits (hereinafter also “DSU benefits”) should have:

- an ISEE/ISEEU Parificato (issued for the sake of obtaining “benefits for the right to higher education”) not higher than **€ 26.516,70**;
- an ISPE/ISPEU calculated by dividing the ISP value (Assets Status Indicator provided by INPS) by the equivalency scale, not higher than **€ 57.645,03**.

Regardless of their merit, students whose ISEE/ISEEU Parificato or ISPE/ISPEU exceeds the abovementioned limits will be excluded from the assignment of DSU benefits.

Independent student

A student is defined as “independent” when the following requirements are met conjunctly:

- the student has had a different and separate residence from their family’s one for at least two years from the subscription of the Dichiarazione Sostitutiva Unica, and such a residence is not located in a property owned by their family;
- the student has been perceiving for two years an own, fiscally declared income derived from an employment relationship or assimilated no lower than **€ 9.000,00**. Such activities must not be carried out under an individual who is bonded to the student through kinship. If the independent student, basing on their civil status certificate, is cohabiting with another person, the incomes of both people must be considered mandatorily, even if they are not relatives.

Even an independent student will be considered “away from home”, if they take up a paid accommodation in the Municipality where their course is held.

ART. 2 ACCUMULATION AND EXCEPTIONS

The art. 12.1 is supplemented as follows:

The scholarship cannot be cumulated with analogous financial aids issued by Politecnico di Milano or by other Public or Private bodies.

Exemptions are applied to:

- scholarships offered by national or Foreign Institutions aimed to integrate with overseas stays the curricular and research activity of the awardees;
- scholarships assigned to students enrolled in a Bachelor of Science, Master of Science, or Single-Cycle Master of Science who participate in national mobility programs, as per Ministerial Decree of March 28th 2024, No. 548;
- for merit-based grants awarded by university institutions to students enrolled in excellence programs.

ART. 3 DSU SCHOLARSHIPS: NUMBER AND VALUE

The art. 13 is supplemented as follows:

there are **4.300** DSU scholarships available, divided up as below:

Income brackets

The income brackets through which DSU scholarship amounts are determined are the following:

Scholarship amounts based on student's income brackets and geographical origin

The DSU scholarship's amounts, considering both the income bracket and student's geographic origin, are determined as follows:

Local student	
1 st bracket	€ 2.565,00 + one free meal per day for a total of € 3.383,00
2 nd bracket	€ 2.132,00 + one free meal per day for a total of € 2.950,00
3 rd bracket	€ 1.296,00 + one free meal per day for a total of € 2.114,00

Commuter student	
1 st bracket	€ 3.936,00 + one free meal per day for a total of € 4.754,00

2 nd bracket	€ 3.316,00 + one free meal per day for a total of € 4.134,00
3 rd bracket	€ 2.436,00 + one free meal per day for a total of € 3.254,00

Away from home student housed in Politecnico di Milano residences

1 st bracket	€ 4.556,00 + housing + one free meal per day for a total of € 8.134,00
2 nd bracket	€ 3.495,00 + housing + one free meal per day for a total of € 7.073,00
3 rd bracket	€ 2.198,00 + housing + one free meal per day for a total of € 5.776,00

Away from home student housed in other accommodations, either public or private

1 st bracket	€ 7.316,00 + one free meal per day for a total of € 8.134,00
2 nd bracket	€ 6.255,00 + one free meal per day for a total of € 7.073,00
3 rd bracket	€ 4.958,00 + one free meal per day for a total of € 5.776,00

For students enrolled in the academic year 2025/2026 who are beneficiary of DSU for their additional term of all courses and students enrolled in the first year of Master of Science courses starting from the second term, the amount of their scholarship, as well as their services' deductions, will be reduced by 50%.



Students with certified disability of 66% or higher can get the annual amount of their scholarship increased up to 40% on top of the one they are entitled to, for a final benefit amounting to a maximum of:

€ 4.736,00 for local students
€ 6.656,00 for commuter students
€ 11.388,00 for away from home students

ART. 4 SCHOLARSHIP'S INCREASE ex DM 1320/2021

In light of article 3.5 of the DM 1320/2021, female students enrolled in STEM subjects (Science, Technology, Engineering, and Mathematics) will benefit from an increase in their scholarship by 20%. As specified by the decree 13676/2022 of Ministero dell'Università e della Ricerca, the 20% increase of the scholarship for STEM students is not cumutable with the abovementioned increase of 15% reserved to students whose ISEE is inferior by 50% of the maximum limit of

reference. Thus, the incrementation is calculated basing on the value of the scholarship which the female student is entitled to (corresponding to the amount of the second and third bracket).

ART. 5 CANTEEN SERVICE DEDUCTION

The art. 19 is supplemented as follows:

A deduction of **€818.00** will be applied to the scholarship amount for awarded students.

50% of this amount will be deducted from the first installment of the scholarship, and the remaining 50% from the second installment.

ART. 6 INTEGRATION OF DSU SCHOLARSHIP TO PARTECIPATE IN INTERNATIONAL MOBILITY PROGRAMS

The art. 20.2 is supplemented as follows:

The contribution of the Scholarship is **€600 per month** for a period spent abroad, which must last **at least 2 months** and up to **10 months**.

If the student receives DSU Scholarship for solely one semester, the contribution for international mobility will be paid for a maximum of five months, calculated from the departure date stated on the mobility contract until **February 28th 2026**.

The amounts of **any other contribution** assigned through European Union funds or other public/private entities, or based on bilateral agreements, even outside the EU, are **deducted** from the amount.

On top of that, students have the right to the reimbursement of round-trip travel expenses to a maximum of **€100** for European countries and **€500** for non-European countries.

The expenses reimbursement must preliminarily deduct the travel contribution which is issued on a kilometers basis and which has already disbursed by the International Mobility Unit.

The reimbursement of travel expenses, if applicable, is subject to the reception of travel documentation.

In particular, the interested student must **send** to the Financial Aid Unit - through the **email channel** indicated on the web page: www.polimi.it/diritto-allo-studio/ > (select: Supplementation for international mobility) - the pertinent documentation to prove the travel expenses **WITHIN a mandatory period of 30 days** from their return from mobility, namely the travel tickets related to the departure for the start of the mobility and the return at the end of the mobility.

The section of journey considered is only and exclusively the one necessary to reach the location – starting from where the course of study is held in Italy - where the mobility is carried out and the one to leave such a location.

All expenses undergone for the usage of private means of transport are **NOT** refundable.

Students who, according to art. 6 of the Agreement for international mobility and internships under the Erasmus Plus program, do not fulfill the terms of the agreement or terminate it before its preestablished end for reasons other than those indicated in art.13 of the same (termination in cases of circumstances that make the execution of the contract impracticable, impossible, or excessively difficult) must return the amount of the supplement for international mobility and internships and the quota relating to travel expenses already paid.

ART. 7 STUDENTS NOT ELIGIBLE FOR THE SCHOLARSHIP

The art. 28.4 is supplemented as follows:

If students who have been assigned a preferential rate residence slot are “ineligible” in the final ranking for assignment of scholarships, they can stay at the assigned residence, but they will be charged the full rate from the date when the residence slot was assigned to them.

Full-rate residence slot for Galileo Galilei, Einstein, Marie Curie and Leonardo da Vinci:

- Single room with private bathroom: €6,545.00 (one-off payment).
- Single room with private bathroom equipped for students with disabilities: €6,545.00 (one-off payment).
- Single room with shared bathroom in an apartment equipped for students with disabilities: €6,330.00 (one-off payment).
- Single room with shared bathroom in an apartment: €6,330.00 (one-off payment).
- Single room with shared bathroom: €6,040.00 (one-off payment).
- Double room with shared bathroom in an apartment: €5,185.00 (one-off payment).
- Double room with private bathroom: €4,780.00 (one-off payment).
- Double room with shared bathroom: €4,580.00 (one-off payment).

Full-rate residence slot for Newton, Pareto, Loos and La Presentazione:

- Double room with shared bathroom in an apartment: €4,830.00 (one-off payment).
- Double room with private bathroom: €4,530.00 (one-off payment).
- Double room with shared bathroom: €4,330.00 (one-off payment).

Full-rate residence slot for Cremona:

- Single room with private bathroom equipped for students with disabilities: €3,850.00 (one-off payment).
- Double room with private bathroom: €3,330.00 (one-off payment).

Ineligible students who do NOT wish to stay in the assigned residence slot, will need to check out by no later than 5 business days after the reception of the notification from the Housing & Dining Unit, paying the full rates for the entire period which they had used the accommodation for since its assignment date.

ART. 8 ACCOMMODATION DEDUCTION FOR STUDENTS HOUSED IN POLITECNICO DI MILANO'S RESIDENCES

Art. 29 of the Call is supplemented as follows:

a **deduction** equal to € 2.808,00. will be made from the amount of the scholarship for students housed in Politecnico di Milano's residences.

ART. 9 REFERRAL

It shall be without prejudice to the provisions of the Call emanated with Management Decree ref. 0130618/2025.
